Michigan Citizens must play an important role in the lawmaking process by informing their representatives in the state legislature of their opinions on issues and needs for the state. Please make an appointment in advance, and understand if the legislator is called away for an unscheduled committee meeting or session. You may meet with a staff member who will be welcoming and attentive to your concerns.</p>		
	<p>By Phone</p>	<p>A phone call is a quick and easy way to contact your legislator. Direct phone numbers are provided in the pages that follow.
