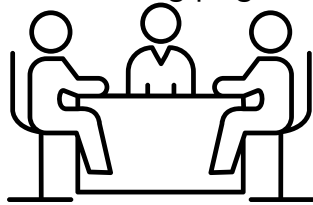

Virtual meetings should be scheduled directly with a staff member.



## Letter

Include your full name and address when sending mail to your legislator so staff can provide a response. MI State Legislators addresses are indicated on the final page.



## Email

Email addresses are provided on the pages that follow. In your email, please include your full name and mailing address.



## Phone

A phone call is a quick and easy way to contact your legislator. Phone numbers are provided in the following pages.

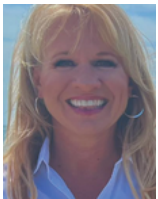
