Area Agency on Aging 1-B is committed to enacting policy change that positively impacts older adults, caregivers and families.

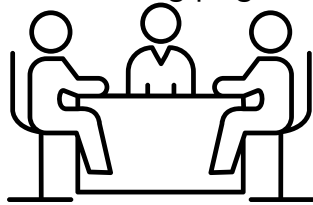

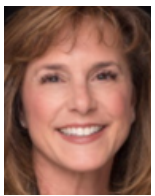

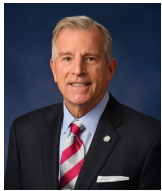
