



AGEWAYS CONTRACTED SERVICES TO BE FUNDED FOR FISCAL YEARS 2027-2029

<p>Adult Day Services</p>	<p>Daytime care of any part of a day, but less than twenty-four-hour care for functionally and/or cognitively impaired elderly persons provided through a structured program of social and rehabilitative and/or maintenance services in a supportive group setting other than the participant's home.</p>
<p>Assistance to the Hearing Impaired and Deaf Community</p>	<p>Assistance to older persons with hearing impairments or who are deaf and/or education and training relative to community services; assistance in obtaining benefits and services; community education on hearing impairments, deafness, and prevention.</p>
<p>Caregiver Legal Assistance</p>	<p>Legal advice, information, and representation is provided to caregivers of older adults or kinship caregivers.</p>
<p>Chore</p>	<p>Specific household maintenance tasks (non-continuous) are provided with the intention to increase the safety and ability of and person(s) living in the residence to maintain their independence.</p>
<p>Community Liaison</p>	<p>Assistance to individuals in finding and working with service providers to meet their needs, which may include information and assistance, group presentations, referrals, advocacy intervention, and follow-up contacts.</p>
<p>Congregate Meals</p>	<p>Daily, nutritionally balanced meals for adults 60 years of age* and older, offered at select community sites that support socialization, health, and wellness.</p> <p><i>* Spouses of any age and/or dependent adult family members may be eligible to receive a meal when they accompany an eligible participant.</i></p>
<p>Disease Prevention and Health Promotion Programs</p>	<p>Evidence-based wellness programs that provide older adults with tools to help manage their health and provide support through group workshops.</p>



<p>Grandparents Raising Grandchildren</p>	<p>Provision of support services (which only include caregiver care management, caregiver education, caregiver information & assistance, caregiver respite care, caregiver supplemental services, and caregiver support groups) in kinship care situations where an individual aged 55 or over is the primary caregiver for a child no more than 18 years old. Kinship support services may be provided at locations other than the participant's residence.</p>
<p>Home Delivered Meals</p>	<p>Nutritionally balanced meals delivered to adults 60 years of age and older who are homebound, unable to prepare meals, are normally unable to leave the home unassisted, and for whom leaving the home independently takes a considerable and taxing effort.</p>
<p>Home Injury Control</p>	<p>Adaptations and devices are installed in homes of older adults to reduce falls and/or minimize the occurrence of injury.</p>
<p>Legal Assistance</p>	<p>Legal advice, information, and representation is provided to older adults.</p>
<p>Prevention of Elder Abuse, Neglect, and Exploitation (PEANE)</p>	<p>Collaborative programs are developed, strengthened, and implemented that raise awareness and prevent elder abuse, neglect, and exploitation.</p>
<p>Volunteer Caregiver</p>	<p>Agencies recruit, match, and manage volunteers who provide respite to caregivers of older adults. Volunteers provide companionship, supervision, assistance with instrumental activities of daily living, and/or transportation.</p>
